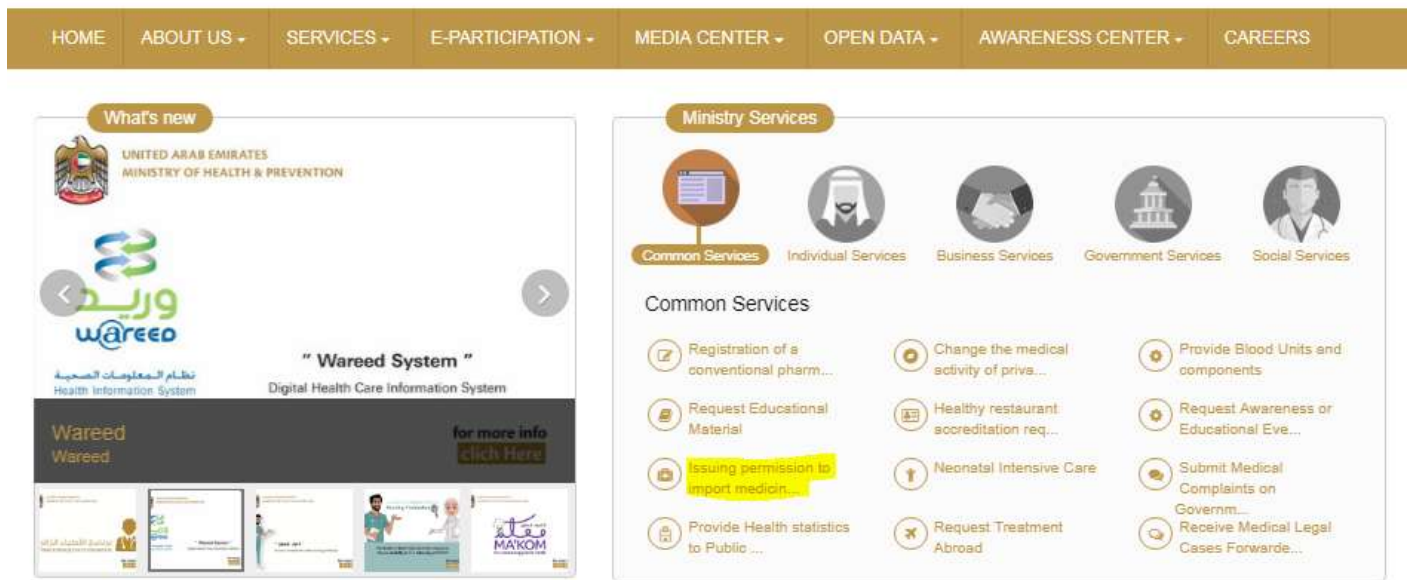

 2. The concerned officer in Drugs Department examines the request.
 3. Drugs Department issues the approval.
 4. Approval is to be handed over/ delivered to the concerned customer.
